#### **TERMS & CONDITIONS FOR BIDDERS**

- 1. The Proposal shall be disqualified if any one of the following conditions is not fulfilled.
  - a) If the proposal is not submitted in a sealed envelope or received in different email address other than the authorized address which is procurement@caritas.org.np.
  - b) If there is no document as mentioned in the vendor Submission Requirement clause.
  - c) If there is no company or firm's seal on the Terms and Conditions document.
  - d) If there is no Proprietor's / Firm's authorized representative's signature in Terms and Conditions document.
- 2. Sealed proposal completed in all respects shall be opened in Central Office and Project Operation Office in Damak, Jhapa. The sealed bids will be opened without the presence of bidders.
- 3. TDS on the total amount shall be deducted from the bill as per the Government rules and regulations and deposited to the Tax Office.
- 4. The quoted price in the form submitted by the bidder will be taken as the submitted correct price.
- 5. All decisions will be taken by Caritas Nepal's Procurement Committee.
- 6. Caritas Nepal reserves the right to accept or reject the proposal without giving any reason whatsoever, or to waive minor irregularities or errors in this quotation and is not obliged to accept the lowest bid.
- 7. The bid application indicates clearly agreement by bidder (vendor/supplier) on supplying Agroinputs by taking part in Caritas Nepal voucher based agriculture input program and to receive payment for sales made every 7-14 days.
- 8. Bidders (vendor/supplier) agree to submit necessary documents in order to receive payment from Caritas Nepal every 7-14 days during contract period. The documents to be submitted will include: invoice, vouchers received from beneficiaries/clients, receipts, and verification document for vouchers received (as advised by Caritas Nepal).

#### **Code of Conduct for suppliers: -**

- 1) Should have Legal status:-( As per mentioned in Vendor Submission Requirement clause)
- 2) Caritas Compliance and national laws: Caritas expects the entities we deal with to comply with government laws relating to protecting the rights of workers including working hours, conditions of work, freedom of association, health and safety, Child Labour (Prohibition and Regulation) Act, 2000, environmental laws, tax laws of the land etc

Caritas Nepal expect suppliers to report to the management any attempt by Caritas Nepal staff to exert pressure, or extract favors or personal gain economically, professionally, politically or sexually.
