EVALUATION MANDATE

The mid-term evaluation of the SAFBIN (Smallholder Adaptive Farming and Biodiversity Network) programme is envisaged as part of the programme proposal. The mandate for organising the external evaluation is stated as part of the programme agreements.

PROGRAMME BACKGROUND

Title: Smallholder Adaptive Farming and Biodiversity Network (SAFBIN) (www.safbin.org)

Programme Duration: April 01, 2018 – March 31, 2022

SAFBIN is an action research programme led by Caritas Organisations of Bangladesh, India, Nepal and Pakistan and supported by Caritas Organisations in Austria, Italy, Luxembourg and Switzerland.

The future of agriculture is in the hands of smallholder farmers. They are not only the target group of SAFBIN but they are the solution. Small-scale farmers are becoming researchers in their own farms. They exhibit higher productivity and cropping intensity while using the simplest means like improved varieties, shifting of sowing dates, seed banks etc. and contribute to reduce consumption of resources for achieving higher income and resilience to climate change.

Though they are the hardest hit by climate change, they are also the best adaptors of the phenomenon through the local practices that are unique to them. Bringing them together, SAFBIN banks upon the smallholder farmers' collectives to achieve the global goals of SDGs in the four countries of Bangladesh, India, Nepal and Pakistan in the South Asia region. The cooperation and the exchange of knowledge across the political boundaries of the four countries are also unique. The programme is headed by Caritas Austria with the support of Caritas Switzerland, Caritas Italy, Caritas Luxembourg and implemented by the Caritas organisations in Bangladesh, India, Nepal and Pakistan.

• Impact:

To contribute to SDG2: End hunger, achieve food security and improved nutrition and promote sustainable agriculture in South Asia

Expected outcomes (OC):

- 1. Food and Nutritional Security and Resilience of Small holder farmer families improved
- 2. Income of the smallholder farmer families have increased

• Outputs (OP)

- 1. Resilient and capacitated Small farm households increased farm production and surplus with adaptation to climate change and disaster while maintaining ecosystem and soil health (merger of former outcomes 1 and 4, except for Value chain outputs 1.2 & 1.3)
- 2. Improved capacities of small farm households to consume a balanced diet (former outcome 2)
- 3. Smallholder farmers enhanced their land tenure security and access to water, seed, entitlements and knowledge (former outcome 3)
- 4. Increased dialogue around Small farmers in policy and actions (around research, extension and technology development) forums (former outcome 5)
- 5. Value chain of Small-Farm-Agri-Foods (SFAF) developed with their sustainable production & consumption (former outcome 6)

EVALUATION OBJECTIVES AND MAIN USERS

i) Rationale of Evaluation:

SAFBIN partners have discussed and planned for the mid-term evaluation at the in the month of April/May, 2021. Baseline and LFA monitoring data for the 3rd year (three quarters) of the programme will be available by the end of March, 2021 to quantify the achievements as per the results framework agreed in the revised contract. The mid-term evaluation will involve the process of carrying out a comprehensive joint external evaluation through involvement of programme stakeholders and national and international experts.

The main objective of this mid-term external evaluation is to review the programme performance after three years of programme implementation. Experiences of farmers and other stakeholders with these process of appraisal-trial design and laying-monitoring and data collection-analysis and refining will help evaluators to better assess the progress, process and impact and suggest mid-course corrections for last year's trial and other recommendations. This evaluation will also review the progress made with respect to the indicators of the results mentioned in the revised programme logframe.

ii) Objectives of the Evaluation

The main objective is to inform on the <u>Relevance</u>, <u>Effectiveness</u>, <u>Efficiency</u>, <u>Sustainability</u> <u>and Impact</u> of the programme in the first three years and to give recommendations on possible advantageous adaptations. The evaluation team shall furthermore analyse the following points:

- What was the added value of the regional aspect of the programme
- Identifying scope of future intervention and future areas; elaborate recommendations for eventual similar interventions in the future
- COVID impact and how the team and communities overcome it

The **main users** of the evaluation findings will be the members of the programme team. The evaluation report will also be shared with Caritas Switzerland, CLUX, Caritas Italy and potential future donors.

EVALUATION SCOPE AND EVALUATION QUESTIONS

i) Evaluation Scope

The impact assessment will focus more on qualitative analysis processes and learning around the interventions enabling process.

ii) Geographical scope:

The programme is being implemented in 94 villages under 11 districts in four countries. The field visits for evaluation would include on-site visits to the selected programme locations lying across Bangladesh, India, Nepal and Pakistan.

iii) Evaluation Period:

This will be an mid-term evaluation covering the programme from April, 2018 to March, 2021.

iv) Methodology, Tools and Main Deliverables

The evaluation is planned to be carried out by a team of independent evaluators selected from each country. SARE (South Asia Regional Enablers) will work with the country level evaluators to generate uniform information required to prepare the consolidated report at the programme level. Each country level evaluator will also evaluate the regional aspects of the programme and the facilitation by SARE in their respective country of evaluation. SARE will facilitate meetings of the evaluators to develop common tools and formats for maintaining the uniformity of country level reports. Each evaluators will be solely responsible for the evaluation at their respective country.

Each evaluators at the country level will independently lead the country level evaluation of their respective country including the regional component and cooperation of SARE at the country level, prepare the final country level report and provide the pre-agreed information to SARE to generate programme level report. They shall visit sample villages in the programme district / country and interact with the relevant stakeholders in the programme. The country level programme report may be shared with SARE for preparing the consolidated report at the programme level.

v) Evaluation Steps & Tools:

The visits of the evaluator will be organised at the programme districts.

Step 2 : Field Visits (Evaluation of Program impact among target population)

- **1.** Focus Group Discussion (FGD) with stakeholder groups viz. SHFC, district forum etc.
- 2. In-depth Interviews (IDI) with Individual Stakeholders viz. farmers, scientists, agri. extension officials, members of local self-governance units, programme team members etc.
- 3. Field Observation: Climate change contexts, quality and quantity of physical interventions, locations, research design, rigour, data collection and analysis, participation, information dissemination and exchange cross learning; yield improvements/resilience
- 4. Debriefing: Initial findings of the evaluation will be shared with the respective teams. SARE/CAUT team will virtually join the debriefing meeting of all partners.

Relevance:

- To what extent the programme and its activities were relevant to overcome the needs of the target population? Do stakeholders care about the programme and believe in its relevance to their challenges?
- Were the activities and outputs of the programme consistent with the overall goal and the attainment of its objectives?
- In what way did the programme use innovative approaches including traditional knowledge system, farmer led institutions etc., and how did they work out?
- Are the poor and disadvantaged sections of the community included/involved in the programme?

Effectiveness:

- To what extent were the outcomes achieved / are likely to be achieved? (please give information on each outcome, especially on climate change adaptation)
- To what extent were the outputs / are likely to be achieved? (please give information on each output)
- What were the major factors influencing the achievements or non-achievements of the outcomes and outputs?
