Term of Reference (ToR) for Facilitation and Preparation of Local Disaster and Climate Resilience Plan under National Housing Settlement and Resilience Platform, Koshi Province

I. Background

This Terms of Reference (ToR) is developed to solicit consultancy support services from qualified individuals or organizations to facilitate consultation workshops and prepare Local Disaster and Climate Resilience Plan for Budhiganga Rural Municipality, Morang District. This assignment is part of the National Housing and Settlement Resilience Platform's technical support to Budhiganga Rural Municipality. Caritas Nepal is the lead agency for the implementation of the activities of the platform in the Koshi Province.

Housing Recovery and Reconstruction Platform (HRRP) is renamed as the National Housing and Settlements Resilience Platform (NHSRP) to signify its move from post-earthquake recovery under the previous NRA, to multi-disaster housing recovery and reconstruction in accordance with the NDRRMA mandate. The current scope of work of NHSRP is to support capacity strengthening of the government by extending support for operational effectiveness of its roadmap towards resilient homes and communities and envisions to influence partners to collaborate for scaling up government capacity to meet future recovery objectives.

2. Objectives of the Assignment

The overall objective of the assignment is to prepare Local Disaster and Climate Resilience Plan (LDCRP) of the Budhiganga Rural Municipality based on LDCRP guidelines.

3. Scope of the Assignment

8. Guidance and Supervision

9. Special Terms & Conditions / Specific Criteria

- The team leader should have a minimum of 5 years of relevant experience, preferably in developing disaster risk reduction or management plans
- •Experience in preparation of LDCRP
- Knowledgeable about disaster risk management and climate change concept and approaches
- An example of at least two similar completed assignments and outputs shall be shared during the discussion meeting.

10. Evaluation Process

After evaluation of the proposals by the procurement committee, the project will make an award to the applicant whose proposal provides the best value considering both technical and financial aspects. There will be 80% marks for technical evaluation and 20 % marks for financial evaluation.
